



Swyftx Best Dad Joke – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx Facebook Giveaway which is a which is open at **12:00pm NZST Thursday 2nd of September 2021, with entries closing on 8.00pm NZST Sunday 5th of September 2021.**
2. The promotion is free to enter and is operated by Swyftx Australia Pty Ltd, ABN 72 623 556 730 of Suite 4D, Level 4, 50 McDougall Street, Milton QLD 4064.
3. To enter the promotion applicants must:
 - a. Be over the age of 18;
 - b. Be residents of New Zealand;
 - c. Have a verified Swyftx account;
 - d. Log in to their personal Facebook account, locate the official competition post titled “Best Dad Joke,” and submit an answer in the comments section during the time the promotion is open;
 - e. Answer the question: **‘In 25 words or less, what is your best dad joke?’**, with an answer which is not inappropriate or offensive (as determined by Swyftx at its sole discretion); and
 - f. Adhere to all of the Rules set out in this document.
4. Winners will be determined by a judge, being a senior executive of Swyftx at **4:00pm NZST on Monday 6th of September 2021**, following the closing time of the competition. This competition is a game of skill, and the winning entries will be judged based on the following criteria:
 - Creativity;
 - Humour; and
 - Uniqueness.
5. The selection of the winners and award of the prize to the winners is final and is not subject to review.
6. There is a total of 5 prize bundles (valued at NZD \$119 each) to be awarded Each prize bundle includes:
 - (a) Bitcoin (BTC) to the value of NZD \$50 (valued at the market rate at the time of deposit); and
 - (b) Swyftx merchandise, including: bottle opener keyring, face mask, stubby holder, cap, socks, cooler bag.

You acknowledge and consent that winning entries may also be published by Swyftx.
10. Winners:-
 - a. Will be contacted by direct message to their Facebook account within 2 business days of the winner being determined, and asked to confirm their acceptance of the prize;
 - b. Will have 30 business days to respond to the Facebook message request confirming their acceptance of the prize, otherwise the next runner up winner will be contacted within 2 business days of this 30 business day period expiring;
 - c. Will be required to provide the email associated with their verified Swyftx account and their preferred postal address to claim all aspects of the bundle prize;
 - i. Will receive the crypto aspect of their prize in the form of Bitcoin (BTC), deposited into their Verified Swyftx account to the value of NZD \$50 (valued at the market rate at the time of deposit), within 5 business days of the winner responding to the email message request confirming their acceptance of the prize;
