



### Swyftx - Tapping Into Crypto Insights – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx Facebook Giveaway which is a which is open on **Thursday 30th of September 2021 2pm NZST**, with entries closing once 500 entries are received or after 48 hours pass from the time of posting, whichever comes first.
2. The promotion is free to enter and is operated by Swyftx Australia Pty Ltd, ABN 72 623 556 730 of Suite 4D, Level 4, 50 McDougall Street, Milton QLD 4064.
3. To enter the promotion applicants must:
  - a. Be over the age of 18;
  - b. Be residents of New Zealand;
  - c. Have a verified Swyftx account;
  - d. Listen to Episode 3 of Tapping Into Crypto – Crypto Tax 101 with Stuart Reynolds
  - e. In response to the Podcast, answer the question: **'In 25 words or less, what is your top crypto tax time insight?'**;
  - f. Submit an answer in the comments of the official competition post on Facebook during the time the promotion is open; and
  - g. Adhere to all of the Rules set out in this document.
4. The 3 winners will be determined once 500 entries are received or after 48 hours pass from the time of posting the competition, whichever comes first. The promotion is not a game of chance and entries will be considered in the order they are received.
5. Winners will be subsequently contacted within 48 hours to organise delivery of their prize.
