



Swyftx Halloween Trick or Treat Competition – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx Halloween Competition which is a which is open at **12:00pm NZST on Thursday the 28th of October 2021**, with entries closing once 16 entries are received or after 6 hours pass from the time of opening, whichever comes first.
2. The promotion is free to enter and is operated by Swyftx Australia Pty Ltd, ABN 72 623 556 730 of Suite 4D, Level 4, 50 McDougall Street, Milton QLD 4064.
3. To enter the promotion applicants must:
 - a. Be over the age of 18;
 - b. Be residents of New Zealand;
 - c. Have a verified Swyftx account;
 - d. Locate:
 - i. the unique code provided on the www.swyftx.com/nz/ website when the applicant successfully locates and clicks on all 5 treat images on the www.swyftx.com/nz/ website (Secret Code); and/or
 - ii. the unique code provided when the applicant successfully locates the golden ghoul image on the www.swyftx.com/nz/ website (Bonus Code);
 - e. Submit a valid entry with the Secret Code and/or the Bonus Code on the Swyftx Halloween Trick or Treat Competition page of the Swyftx Website during the time the promotion is open; and
 - f. Adhere to all of the Rules set out in this document.
4. Winners will be determined at **6:00pm NZST on Thursday the 28th of October** based on the time of entry. The promotion is not a game of chance and entries will be considered in the order they are received.
5. There is a total of 16 prizes to be awarded:
 - a. 15 prizes of NZD\$50 worth of Bitcoin, for the first 15 valid applicants who successfully submitted the Secret Code based on the time of entry, NZST;
 - b. 1 prize of NZD\$250 worth of Bitcoin, for the first valid applicant who successfully submits the Bonus Code based on the time of entry, NZST.
6. An applicant can only submit one valid entry containing the Secret Code and one valid entry containing the Bonus Code. Subsequent entries by the same applicant with either the Secret

Code or the Bonus Code will be void and disregarded. Entries with the incorrect code will be void and invalid.

7. The judge, being a senior executive of Swyftx, will review the entries in the order in which they were received and will determine:
 - a. The winners of the NZD\$50 BTC prizes, who will be the first 15 valid entries who correctly submitted the Secret Code from the time to promotion opened for entries; and
 - b. The winner of the NZD\$250 BTC prize, who will be the first valid entry which correctly submitted the Bonus Code from the time the promotion opened for entries.
8. The judges decision is final and is not subject to review.

Announcements of the winners will take place on **Monday the 1st of November at 2:00pm NZST**, including publication of the winners first name and first initial of last name on the Swyftx [NZ Competition Terms & Conditions](#) page. You acknowledge and consent that winning entries may also be published by Swyftx.
10. The value of the BTC forming the prize is set in NZD and will be realised when the prize is awarded
11. Winners:-
 - a. Will be contacted by email/message to their Swyftx account;
 - b. Will have 30 business days to respond to the email/message request confirming their acceptance of the prize, otherwise the next runner up winner will be contacted within 2 business days of this 30 business day period expiring;
 - c. Will receive their prize as a credit of the prize to their Swyftx account within 5 days of the end of the promotion;
 - d. Will be required to provide the email associated with their verified Swyftx account and their preferred postal address to claim all aspects of the bundle prize;
 - e. May be required to pass further KYC (anti-money laundering and countering financing of terrorism checks) in order to withdraw any prize from their account or transfer such aspect of their prize to another digital wallet; and
 - f. Should seek their own tax advice as to the financial or taxation consequences of receiving Bitcoin (BTC).
