



Swyftx Learn Insights – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx Instagram Giveaway which is open on **Thursday 24th of March 2022 4pm AEST** and closing on **Friday 25th of March 2022 9am AEST** or once 500 entries are received, whichever comes first.
2. The promotion is free to enter and is operated by Swyftx Australia Pty Ltd, ABN 72 623 556 730 of Suite 4D, Level 4, 50 McDougall Street, Milton QLD 4064.
3. To enter the promotion applicants must:
 - a. Be over the age of 18;
 - b. Be residents of Australia;
 - c. Have a verified Swyftx account;
 - d. Go to the Swyftx Learn Platform and read the 'What is the Metaverse?-' <https://learn.swyftx.com/metaverse/what-is-the-metaverse/>
 - e. Answer the question: **'In 25 words or less, what did you learn about the metaverse from the 'What is the Metaverse?' article on the Swyftx Learn platform?'**
 - f. Submit an answer in the comments of the official competition post on Instagram during the time the promotion is open; and
 - g. Adhere to all of the Rules set out in this document.
4. The 3 winners will be determined once 500 entries are received or after 17 hours pass from the time of posting the competition, whichever comes first. The promotion is not a game of chance and entries will be considered in the order they are received.
5. Winners will be subsequently contacted within 48 hours to organise delivery of their prize.
6. There is a total of 3 Prizes to be awarded:
 - a. 1st Prize: \$150 AUD worth of USDT (Tether)
 - b. 2nd Prize: \$150 AUD worth of USDT (Tether)
 - c. 3rd Prize: \$150 AUD worth of USDT (Tether)
7. An applicant can submit one comment as an entry. Subsequent entries by the same applicant under the same Instagram Account, on the same round, will be void and disregarded.

8. The judge, being a senior executive of Swyftx, will review the entries in the order in which they were received and will determine:
 - a. The winners of the competition are those that have been chosen to have the top five creative or informative answers to the question: **'In 25 words or less, what did you learn about the metaverse from the "What is the Metaverse?" article on the Swyftx Learn platform?'**

 - b. The winners will receive their reward in the form of a USDT (Tether) deposit into their Swyftx account within 5 days of the end of the promotion.
