



Bitcoin Pizza Day – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx Bitcoin Pizza Day Competition which is open at **12:00pm AEST on Friday the 20th May 2022**, with entries closing 72hrs later at **12:00pm AEST Sunday 22nd May 2022**
2. The promotion is free to enter and is operated by Swyftx Australia Pty Ltd, ABN 72 623 556 730 of Milton QLD 4064.
3. To enter the promotion applicants must:
 - a. Be over the age of 18;
 - b. Be residents of Australia;
 - c. Have a verified Swyftx account;
 - d. Answer the question: **Tell us what toppings would you put on the Ultimate Bitcoin Pizza?**
 - e. Submit an answer in the comments of the official competition posts on either Facebook and Instagram during the time the promotion is open; and
 - f. Adhere to all the Rules set out in this document.
4. Winners will be determined on **Monday 23rd May 2022**. The promotion is not a game of chance and entries will be considered in the order they are received.
5. There is a total of 3 prizes to be awarded:
 - a. 1 prize of AUD \$1000 of Bitcoin (BTC) for the comment with the most likes, and 1-year supply worth of pizza described in (b) below.
 - b. 2 additional prizes of 1-year's supply worth of pizzathrough 52 x Single use voucher codes for prize winners
 - i. 1 year's supply of pizza is 1 pizza per week for the year (52 pizzas) with Domino's delivered (Choose from: Premium, Vegan, Vegetarian-Plant Based, Traditional or value)
 - ii. All 52 codes are for the same offer
 - iii. Single-use voucher codes are valued for 12 months from the date of creation
6. An applicant can submit one comment as an entry. Subsequent entries by the same applicant under the same Facebook and Instagram Account, on the same round, will be void and disregarded.
7. The judge, being an employee of Swyftx, will review the entries in the order in which they were received and will determine:

- a. The winners of the competition are those that have been chosen to have the top three comments with most likes and reactions that answers the question: **What toppings would you put on your ultimate Bitcoin Pizza?**
8. The judges decision is final and is not subject to review.
9. Announcements of the winners will take place on **Tuesday 24th May 2022**, including publication of the winners first name and first initial of last name on the Swyftx [AU Competition Terms & Conditions](#) page. You acknowledge and consent that winning entries may also be published by Swyftx.
10. The value of the prizes is calculated in AUD, which will be traded into the applicable cryptocurrency on the day that the prize is awarded.
11. Winners:-
 - a. Will be contacted by email/message to their Swyftx account and social account;
 - b. Will have 30 business days to respond to the email/message request confirming their acceptance of the prize, otherwise, the next runner up winner will be contacted within 2 business days of this 30 business day period expiring;
 - c. Will receive their prize as a credit of the prize to their Swyftx account within 5 days of the end of the promotion;
 - d. Will be required to provide the email associated with their verified Swyftx account;
 - e. Will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledge that Swyftx may use any such marketing and editorial material without further reference or compensation to them.
 - f. May be required to pass further KYC (anti-money laundering and countering financing of terrorism checks) in order to withdraw any prize from their account or transfer such aspect of their prize to another digital wallet; and
 - g. Must seek their own tax advice as to the financial or taxation consequences of receiving any prize. Swyftx accepts no responsibility for any tax implications.
12. Swyftx complies with all consumer protection and privacy laws, including the Australian Consumer Law and the Privacy Act.
13. This promotion is in no way sponsored, endorsed, administered by, or associated with Facebook or Instagram.
14. The information collected during this promotion will be dealt with in accordance with our privacy policy and terms and conditions.
15. Entry is not open to any directors, employees, contractors of Swyftx or their families.

16. These Terms and Conditions may be adjusted if required by regulatory or government authority without notice.
17. Swyftx reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions. In the event that there is a dispute concerning the conduct of the promotion or claiming a prize, Swyftx will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved Swyftx's decision will be final.

Any legal proceedings concerning the operations of the promotion will be subject to the exclusive jurisdiction of the courts of Queensland and governed by the laws of Queensland. Prior to commencing any dispute, entrants are obliged to make best efforts to settle the dispute amicably with Swyftx. Failing this, the parties must first submit to mediation before any formal legal proceedings.

If for any reason any aspect of this promotion is not capable of running as planned, including (but not limited to) by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of Swyftx, Swyftx may in its sole discretion cancel, terminate, modify or suspend the promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulations.
19. Swyftx reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by Swyftx to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Swyftx's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid.
