



NRL Learn and Win – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx x NRL Learn and Win Competition which is open at **3:30pm AEST on Wednesday 24th August 2022**, with entries closing 23 days later at **12:00pm AEST on Friday 16th September 2022**.
2. The promotion is free to enter and is operated by Swyftx Pty Ltd, ABN 72 623 556 730 of Milton QLD 4064.
3. To enter the promotion applicants must:
 - a. Be over the age of 18;
 - b. Be a resident of Australia;
 - c. Have a verified Swyftx account (to redeem \$500AUD of BTC aspect of the prize);
 - d. Complete the Learn and Win Quiz on the landing page: <https://swyftx.com/au/learn-and-win-nrl/>;
 - e. Answer the question: **If you were to create your own cryptocurrency what would you call it?**;
 - f. Provide full name and email address on completion of the Learn and Win Quiz; and
 - g. Adhere to all the Rules set out in this document.
4. Winners will be determined on **Monday 19th September 2022**. The promotion is not a game of chance and entries will be considered in the order they are received.
5. There is a total of 1 prize to be awarded to 1 winner:
 - a. The 1 winner will receive:-
 - i. 2 x Diamond General Admission passes to the NRL Grand Final on October 2nd 2022 at the Accor Stadium, Sydney. Competing teams TBD.
 - ii. \$500AUD worth of BTC as valued at time of transfer.
 - iii. 1 x Night Accommodation in a Standard twin room (2 adults) at The Ibis Sydney Olympic Park Hotel, Sydney for the night of October 2nd 2022.
 - iv. 1 x \$1,000 Prezee Jetstar voucher.
6. An applicant can submit one entry. Subsequent entries by the same applicant under the same name, who completes the quiz, will be void and disregarded.

7. The judge, being an employee of Swyftx, will review the entries in the order in which they were received and will determine:
 - a. The winner of the competition is the entrant chosen to have the best response to the question outlined at section 3 above: **If you were to create your own cryptocurrency what would you call it?**
8. Announcements of the winners will take place on **Wednesday 21st September 2022**, including publication of the winners first name and first initial of last name on the Swyftx [AU Competition Terms & Conditions](#) page. You acknowledge and consent that the winning entry may also be published by Swyftx.
9. The winner (and, where relevant, their chosen accompanying guest):-
 - a. Will be contacted by email by an employee of Swyftx.
 - b. Will have 2 business days to respond to the email/message request confirming their acceptance of the prize, otherwise, the next runner up winner will be contacted within 1 business day of this 2 business day period;
 - c. Will be required to provide the email associated with their verified Swyftx account to redeem the \$500 AUD of BTC.
 - d. Will be available to attend the NRL Grand Final on 2nd October 2022 at the Accor Stadium, Sydney.
 - e. Will have all tickets transferred to their nominated email.
 - f. Will be responsible for paying for any additional room charges/services outside of the Twin room prepaid from Swyftx as outlined in Section 5.
 - g. Agree to the T&C's outlined on Prezzee's site regarding the Jetstar voucher - <https://www.prezzee.com.au/store/jetstar-gift-card/>
 - h. Will comply will all requirements enforced by The Accor Stadium, including their conditions of entry.
 - i. Will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledge that Swyftx may use any such marketing and editorial material without further reference or compensation to them.
10. Spending money, meals, accommodation, transport to and from The Accor Stadium, transfers, and all other ancillary costs (except where expressly outlined above) are not included. For the avoidance of doubt, winners and their chosen accompanying guest must make their own travel arrangements to attend The Accor Stadium. Prize must be taken to coincide with the corresponding NRL Grand Final (Competing teams TBD) on Sunday 2nd October 2022.

12. This promotion is in no way sponsored, endorsed, administered by, or associated with Facebook or Instagram.
13. The information collected during this promotion will be dealt with in accordance with our Privacy Policy and Terms of Use.
14. Entry is not open to any directors, employees, contractors of Swyftx or their families.
15. These Terms and Conditions may be adjusted if required by regulatory or government authority without notice.
16. Swyftx reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions. In the event that there is a dispute concerning the conduct of the promotion or claiming a prize, Swyftx will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved Swyftx's decision will be final.

Any legal proceedings concerning the operations of the promotion will be subject to the exclusive jurisdiction of the courts of Queensland and governed by the laws of Queensland. Prior to commencing any dispute, entrants are obliged to make best efforts to settle the dispute amicably with Swyftx. Failing this, the parties must first submit to mediation before any formal legal proceedings.

If for any reason any aspect of this promotion is not capable of running as planned, including (but not limited to) by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of Swyftx, Swyftx may in its sole discretion cancel, terminate, modify or suspend the promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulations.
18. Swyftx reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by Swyftx to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Swyftx's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid.

Swyftx and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence or wilful misconduct) in connection with this promotion or accepting or using any prize (or recommendation), except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

Any losses, expenses, damages, costs or personal injuries caused by the winner or their chosen guests arising out of the use of any prize will be the sole responsibility of the winner and/or their chosen guests.
