



Swyftx Eff You 2022 Competition – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx Eff You 2022 Competition which is open at **9:00 am AEST on Friday 30th December 2022**, with entries closing 72hrs later at **9:00 am AEST Monday 2nd January 2023**.
2. The promotion is free to enter and is operated by Swyftx Pty Ltd, ABN 72 623 556 730 of Milton QLD 4064.
3. To enter the promotion, applicants must:
 - a. Be over the age of 18;
 - b. Be a resident of Australia;
 - c. Have a verified Swyftx account; (to redeem any cryptocurrency aspect of the prize)
 - d. Respond to the statement: **In 25 words or less, give us your best crypto-related roast for 2022.**
 - e. Submit an answer in the comments of the official competition posts on Instagram, Facebook or Twitter during the time the promotion is open; and
 - f. Adhere to all the Rules set out in this document.
4. Winners will be determined on **Tuesday 3rd January 2023**. The promotion is not a game of chance, it is a game of skill and entries will be considered in accordance with these Rules.
5. There is a total of 30 prize packs to be won, with 10 winners being chosen per platform (Facebook, Instagram and Twitter) (30 winners in total);
 - a. There is a total of 6 first place prizes with 2 winners being chosen per platform as outlined in this section 5, each first-place winner will receive:
 - i. 1 x \$500AUD JB Hi-Fi Voucher (Valid at participating stores – JB Hi-Fi T&C's apply);
 - ii. \$200AUD worth of Bitcoin (BTC) as valued at time of transfer;
 - iii. \$150AUD worth of Ethereum (ETH) as valued at time of transfer;
 - iv. \$100AUD worth of Polygon (MATIC) as valued at time of transfer; and
 - v. \$50AUD worth of Polkadot (DOT) as valued at time of transfer.
 - b. There is a total of 6 second place prizes with 2 winners being chosen per platform as outlined in this section 5, each second-place winner will receive:
 - i. 1 x \$200AUD JB Hi-Fi Voucher (Valid at participating stores – JB Hi-Fi T&C's apply);

- ii. \$150AUD worth of Bitcoin (BTC) as valued at time of transfer;
 - iii. \$100AUD worth of Ethereum (ETH) as valued at time of transfer; and
 - iv. \$50AUD worth of Polkadot (DOT) as valued at time of transfer.
- c. There is a total of 9 third-place prizes with 3 winners being chosen per platform as outlined in this section 5, each third-place winner will receive:
 - i. 1 x \$50AUD JB Hi-Fi Voucher (Valid at participating stores – JB Hi-Fi T&C's apply);
 - ii. \$25AUD worth of Bitcoin (BTC) as valued at time of transfer; and
 - iii. \$25AUD worth of Ethereum (ETH) as valued at time of transfer.
- d. There is a total of 9 runner-up prizes with 3 winners being chosen per platform as outlined in this section 5, each runner-up winner will receive a Swyftx Merch pack that includes:

 - ii. 1x Swyftx Tote Bag;
 - iii. 1 x Swyftx Keep Cup;
 - iv. 1 x Swyftx Stubby Holder; and
 - v. 1 x Swyftx Pop Socket.
- 6. An applicant can submit one comment as an entry across each social media platform. Subsequent entries by the same applicant under the same Facebook, Twitter, or Instagram account, on the same platform/post, will be void and disregarded.
- 7. The judge, being an employee of Swyftx, will review the entries in the order in which they were received and will determine the winners of the competition based on the below criteria:
 - a. those that have been chosen to have the comments with the most creative and humorous answers.
- 8. Announcements of the winners will take place on **Wednesday 4th January, 2023**, including publication of the winners' first name and the first initial of their last name on the Swyftx [AU Competition Terms & Conditions](#) page. You acknowledge and consent that the winning entry may also be published by Swyftx.
- 9. The winners:
 - a. Will be contacted by email/message to their Swyftx account and/or social media account;

- b. Will have 2 business days to respond to the email/message request confirming their acceptance of the prize, otherwise, the next runner-up winner will be contacted within 1 business day of this 2 business day period;
 - c. Will be required to provide the email associated with their verified Swyftx account to redeem the crypto portion of their corresponding prize;
 - d. Will be required to provide an address for any physical component of their prize for delivery;
 - e. Agree to the terms and conditions outlined on [JB Hi-Fi's site](#) regarding their gift cards; and
 - f. Will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledge that Swyftx may use any such marketing and editorial material without further reference or compensation to them.
10. Swyftx complies with all consumer protection and privacy laws, including the Australian Consumer Law and the Privacy Act.
 11. This promotion is in no way sponsored, endorsed, administered by, or associated with Facebook, Instagram, Twitter, or JB Hi-Fi.
 12. The information collected during this promotion will be dealt with in accordance with our Privacy Policy and Terms of Use.
 13. Entry is not open to any directors, employees, contractors of Swyftx or their families.
 14. These Terms and Conditions may be adjusted if required by regulatory or government authority without notice.
 15. Swyftx reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions. In the event that there is a dispute concerning the conduct of the promotion or claiming a prize, Swyftx will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved, Swyftx's decision will be final.
- Any legal proceedings concerning the operations of the promotion will be subject to the exclusive jurisdiction of the courts of Queensland and governed by the laws of Queensland.  17. Swyftx reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that

a winner cannot provide suitable proof as required by Swyftx to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Swyftx's discretion be deemed invalid and not eligible to win.
