



Swyftx eBook x NRL Competition – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx eBook x NRL Competition which is open at **12:00 am AEST on Monday 13th February 2023**, with entries closing at **5:00 pm AEST Monday 20th February 2023**.
2. The promotion is free to enter and is operated by Swyftx Pty Ltd, ABN 72 623 556 730 of Milton QLD 4064.
3. To enter the promotion applicants must:
 - a. Be over the age of 18;
 - b. Be a resident of Australia;
 - c. Enter your first name and email in the corresponding fields on the NRL Landing page - <https://learn.swyftx.com/crypto-handbook-nrl-learn-and-win/>
 - d. Download the Swyftx Crypto eBook from the NRL landing page outlined above; and
 - e. Adhere to all the Rules set out in this document.
4. Winners will be determined on **Tuesday 21st February 2023**. The promotion is a game of chance with the winner being randomly chosen. The winner will be chosen by using a random number generator on random.org. The number generated by random.org will correspond to the chosen entrant on a list of all eligible entrants.
5. There is a total of 1 prize to be awarded to 1 winner;
 - a. The 1 winner will receive;
 - i. 2 x Standard 2023 NRL season passes to the club of their choice (This prize is subject to any applicable terms and conditions imposed by the prize provider)

The total value of the prize ranges between \$270 to \$650, depending on the club selected.
6. To redeem the 2 x season passes, the winner and accompanying guest must:
 - i. choose the same club for each season pass;
 - ii. take the prize to coincide with the corresponding chosen NRL club's home games between the dates of 2nd March 2023 to the 3rd September 2023.
7. An applicant can submit one entry on the same platform, any further entries will be void and disregarded.
8. Any Swyftx Crypto eBook downloaded outside of the NRL landing page will not be considered an entry into this competition. Only downloads and details captured from our [NRL page](#) on the promotion dates will go into the draw to win the prize outlined in these Terms & Conditions.

9. The judge, being an employee of Swyftx, will be responsible for using the random.org number generator and determining the 1 random winner.
10. Announcements of the winners will take place on **Wednesday 22nd February 2023**, including publication of the winners first name and first initial of last name on the Swyftx [AU Competition Terms & Conditions](#) page. You acknowledge and consent that the winning entry may also be published by Swyftx.
11. The winners:-
 - a. Will be contacted by the email used to download the Swyftx Crypto eBook;
 - b. Will have 2 business days to respond to the email/message request confirming their acceptance of the prize, otherwise, the next runner-up winner will be contacted within 2 business day of this 2 business day period;
 - c. Will need to provide any required personal details for the winner and accompanying guest in order to receive their 2 x season passes;
 - d. Will not be able to use their season pass to attend any away games, passes will only include the home games of their chosen NRL team;
 - e. Will not be able to use their season pass to attend any 2023 NRL finals games;
 - f. Will comply will all requirements enforced by the chosen teams' stadium, including their conditions of entry.
 - g. Agree to the T&Cs outlined on the chosen clubs site regarding any membership/season pass - <https://www.nrl.com/membership/>
 - h. The winner & accompanying guest may need to register/become members of their chosen club (if not already) to redeem this prize; and
 - i. Will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledge that Swyftx may use any such marketing and editorial material without further reference or compensation to them.

14. The information collected during this promotion will be dealt with in accordance with our Privacy Policy and Terms of Use.
15. Entry is not open to any directors, employees, contractors of Swyftx or their families.
16. These Terms and Conditions may be adjusted if required by regulatory or government authority without notice.

17. Spending money, meals, drinks, accommodation, transport to and from any NRL game, transfers, and all other ancillary costs (except where expressly outlined above) are not included. For the avoidance of doubt, winners and their chosen accompanying guests must make their own travel arrangements to attend any 2023 NRL game.
18. Swyftx reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions. In the event that there is a dispute concerning the conduct of the promotion or claiming a prize, Swyftx will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved Swyftx's decision will be final.

Any legal proceedings concerning the operations of the promotion will be subject to the exclusive jurisdiction of the courts of Queensland and governed by the laws of Queensland. Prior to commencing any dispute, entrants are obliged to make best efforts to settle the dispute amicably with Swyftx.
