



Swyftx x Brisbane Lions Competition – Rules of Entry

1. These are the terms and conditions and rules of entry (**Rules**) of the Swyftx x Brisbane Lions Competition which is open at **6:00 pm AEST on Thursday 16th March 2023**, with entries closing at **3:00 pm AEST Monday 20th March 2023**.
2. The promotion is free to enter and is operated by Swyftx Pty Ltd, ABN 72 623 556 730 of Milton QLD 4064.
3. To enter the promotion, applicants must:
 - a. Be over the age of 18;
 - b. Be a resident of Australia;
 - c. Have a verified Swyftx account;
 - d. Answer the question: **In 25 words or less, who is your favourite Brisbane Lions player and why?**
 - e. Submit an answer in the comments of one of the official competition posts on Facebook, Instagram or Twitter during the time the promotion is open; and
 - f. Adhere to all the Rules set out in this document.
4. Winners will be determined on **Monday 20th March 2023**. The promotion is a game of chance with the winners being randomly chosen. The winners will be chosen by using a random number generator on random.org. The number generated by random.org will correspond to the chosen entrant on a list of all eligible entrants.
5. There is a total of 5 prizes to be awarded to 5 winners drawn from the total pool of eligible entrants from all platforms;
 - a. The 5 winners will each receive the following:
 - i. 2 x General Admission tickets to the Brisbane Lions vs Melbourne Demons game at The Gabba Stadium, Brisbane, on the 24th March 2023.
6. An applicant can submit one entry. Subsequent entries by the same applicant under the same name on the same platform, will be void and disregarded.
7. Announcements of the winners will take place on **Thursday 23rd March, 2023**, including publication of the winners first name and first initial of last name on the Swyftx [AU Competition Terms & Conditions](#) page. You acknowledge and consent that the winning entry may also be published by Swyftx.

8. The winners (and, where relevant, their chosen accompanying guest):-
 - a. Will be contacted by email/message to their social media account that entered the Competition;
 - b. Will have 2 business days to respond to the email/message request confirming their acceptance of the prize, otherwise, the next runner-up winner will be contacted within 1 business day of this 2 business day period;
 - c. Will be required to provide the email associated with their verified Swyftx account;
 - d. Will be available to attend the game on Friday 24th March 2023 – Brisbane Lions vs Melbourne Demons at The Gabba Stadium, Brisbane.
 - e. Will have all tickets transferred to their nominated email;
 - f. Will comply with all requirements enforced by The Gabba Stadium, including their conditions of entry.
 - g. Will participate in and co-operate as required with all reasonable marketing and editorial activities relating to the promotion, including (but not limited to) being recorded, photographed, filmed or interviewed and acknowledge that Swyftx may use any such marketing and editorial material without further reference or compensation to them.
9. Spending money, meals, accommodation, transport to and from The Gabba, transfers, and all other ancillary costs (except where expressly outlined above) are not included. For the avoidance of doubt, winners and their chosen accompanying guests must make their own travel arrangements to The Gabba Stadium, Brisbane, Queensland. Prize must be taken to coincide with the corresponding AFL Game (Brisbane Lions vs Melbourne Demons) on Friday 24th March 2023.
10. Swyftx complies with all consumer protection and privacy laws, including the Australian Consumer Law and the Privacy Act.
11. This promotion is in no way sponsored, endorsed, administered by, or associated with Facebook, Instagram or Twitter.
12. The information collected during this promotion will be dealt with in accordance with our Privacy Policy and Terms of Use.
13. Entry is not open to any directors, employees, contractors of Swyftx or their families.
14. These Terms and Conditions may be adjusted if required by regulatory or government authority without notice.
15. Swyftx reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions. In the event that there is a dispute concerning the conduct of the promotion or claiming a prize, Swyftx will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved Swyftx's decision will be final.

Any legal proceedings concerning the operations of the promotion will be subject to the exclusive jurisdiction of the courts of Queensland and governed by the laws of Queensland. Prior to commencing any dispute, entrants are obliged to make best efforts to settle the dispute amicably with Swyftx. Failing this, the parties must first submit to mediation before any formal legal proceedings.

If for any reason any aspect of this promotion is not capable of running as planned, including (but not limited to) by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of Swyftx, Swyftx may in its sole discretion cancel, terminate, modify or suspend the promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulations.
17. Swyftx reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that a winner cannot provide suitable proof as required by Swyftx to validate their entry, the winner will forfeit the prize in whole and no substitute will be offered. Incomplete, indecipherable, inaudible, incorrect and illegible entries, as applicable, will at the Swyftx's discretion be deemed invalid and not eligible to win. Entries containing offensive or defamatory comments, or which breach any law or infringe any third party rights, including intellectual property rights, are not eligible to win. The use of any automated entry software or any other mechanical or electronic means that allows an individual to automatically enter repeatedly is prohibited and may render all entries submitted by that individual invalid.
