

Swyftx 1 Year Teach Me Tuesday Competition - Rules of Entry

- These are the terms and conditions and rules of entry (Rules) of the Swyftx 1 Year Teach Me Tuesday Competition which is open at 5:00 pm AEST on Tuesday 4th July 2023, with entries closing at 5:00 pm AEST Wednesday 5th July 2023.
- 2. The promotion is free to enter and is operated by Swyftx Pty Ltd, ABN 72 623 556 730 of Milton QLD 4064.
- 3. To enter the promotion, applicants must:
 - a. Be over the age of 18;
 - b. Be a resident of Australia;
 - c. Have a verified Swyftx account (or create a verified Swyftx account to redeem the prize);
 - d. Follow the link https://swyftx.com/au/teach-me-tuesday/, from our Instagram story posted on the 4th of July;
 - e. Fill out the form including the correct answer of what the winning prize word was;
 - f. Adhere to all the Rules set out in this document.
- 4. Winners will be determined on **Thursday 6th July 2023**. The promotion is a game of chance with the winners being randomly chosen. The winners will be chosen by using a random number generator on random.org. The number generated by random.org will correspond to the chosen entrant on a list of all eligible entrants.
- 5. There is a total of 1 prize to be awarded to 1 winner drawn from the total pool of eligible entrants from the entry form on our landing page;
 - a. The 1 winner will receive the following:
 - i. \$300AUD worth of any crypto asset listed on Swyftx, chosen by the winner (Valued at the time of transfer, as determined by Swyftx)
- 6. An applicant will automatically be entered into the promotion when they have completed the entry form on our landing page with the correct winning word from our Teach Me Tuesday Instagram story—https://www.instagram.com/swyftx/
- 7. If claimed within the specified timeframe in section 8 (b), announcements of the winners will take place on Friday 8th July, 2023, including publication of the winners first name and first initial of last name on the Swyftx <u>AU Competition Terms & Conditions</u> page. You acknowledge and consent that the winning entry may also be published by Swyftx.

- b. Will have 2 business days to respond to the email/message request confirming their acceptance of the prize, otherwise, the next runner-up winner will be contacted within 1 business day of this 2 business day period;
- c. Will be required to provide/confirm the email associated with their verified Swyftx account:
- d. Will provide which crypto they would like to be credited. The asset must be listed on Swyftx at the time of transfer.

- 12. The information collected during this promotion will be dealt with in accordance with our Privacy Policy and Terms of Use.
- 13. Entry is not open to any directors, employees, contractors of Swyftx or their families.
- 14. These Terms and Conditions may be adjusted if required by regulatory or government authority without notice.
- 15. Swyftx reserves the right to disqualify entries in the event of non-compliance with these Terms and Conditions. In the event that there is a dispute concerning the conduct of the promotion or claiming a prize, Swyftx will resolve the dispute in direct consultation with the entrant. If the dispute cannot be resolved Swyftx's decision will be final.
 - Any legal proceedings concerning the operations of the promotion will be subject to the exclusive jurisdiction of the courts of Queensland and governed by the laws of Queensland. - 17. Swyftx reserves the right, at any time, to validate and check the authenticity of entries and entrant's details (including an entrant's identity, age and place of residence). In the event that
