Tapping Into Crypto x Australian Crypto Convention Competition – Rules of Entry

- These are the terms and conditions and rules of entry (Rules) of the TIC x ACC23 Competition which is open at 12:00 pm AEST on Thursday 26th October 2023, with entries closing at 12:00 pm AEST Monday 30th October 2023.

 - a. Be over the age of 18;
 - b. Be a resident of Australia;

 - d. Adhere to all the Rules set out in this document.
